Terms and Conditions:

TriCord Tradeshow Services (hereinafter referred to as "TriCord") is our exclusive exhibit hall service contractor for our convention at the Disneyland Hotel® in Anaheim. TriCord will provide drayage, material handling, additional furniture, cleaning, specialty carpet, installation/dismantle supervision and labor. **TriCord will send kit options to all registered exhibitors once registration is processed.** Telephone services, meeting room internet, electrical and audio/visual are provided by Disneyland Hotel® and their contracted AV provider, PSAV.

All exhibitors agree to the Terms and Conditions of Disneyland Hotel® Policies and Procedures, and the regulations of Anaheim Fire Department. A copy of the terms and conditions for Disneyland Hotel® will be provided to an exhibitor upon request.

Booth spaces are reserved on a first come – first served basis. **Full payment** must accompany booth registration application in order to hold your booth choice. We have space for **70** Booths – book early as we usually sell out. If you are interested in displaying a vehicle, any and all charges that are associated with the move in and move out, security, protection materials, etc. will be at the expense of the exhibitor. Booth placement will be determined by PCOC and the Disneyland Hotel® ONLY, as the venue requires vehicle placement in certain areas of the Exhibit Hall. **Please include your intent to display a vehicle with your registration.** In case of cancellation, a full refund will be given only upon written request if received prior to March 1, 2022. If written cancellation is received after March 1, 2022 through April 1, 2022, a 50% refund will be given. **After April 1, 2022, NO REFUNDS will be given. There will be no refund for cancellations received after that date.** PCOC and TriCord will do their best to accommodate your exhibit placement wishes but reserves the right to change the configuration of the exhibit hall and relocate exhibits if necessary.

The Exhibitor assumes the entire responsibility and liability for losses, damages, claims arising out of injury, loss, or damage of exhibitor's displays, equipment, or other property brought upon the premises of Disneyland Hotel®. 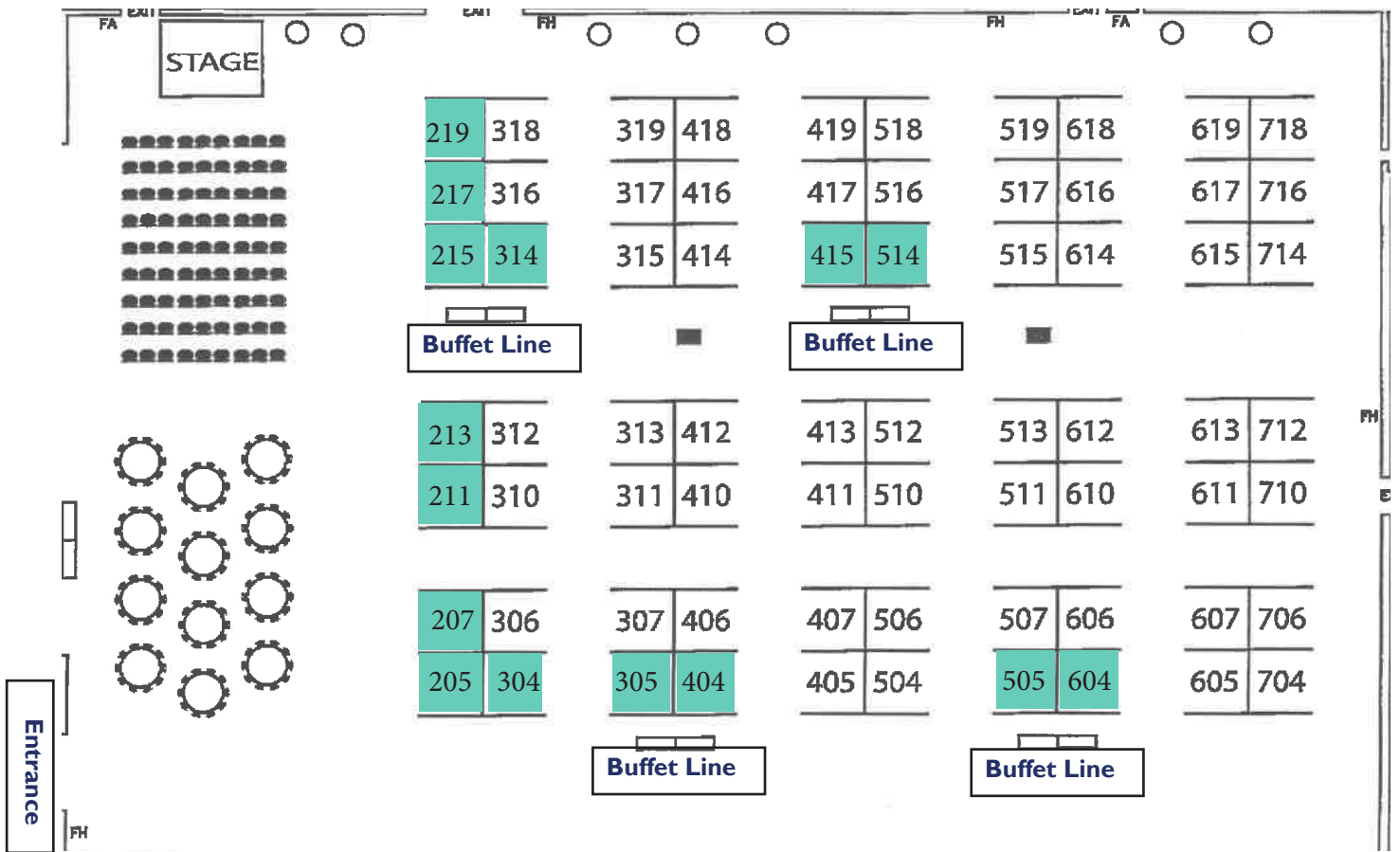
